To Whom It May Concern:

Beginning in July 2003 your agency has been involved with the above named three children on a very lax and irregular basis. A duration period of 30 months to date.

Throughout this time period there have been multiple concerns raised to your agency in regards to the safety, well being and mental and physical health of these three children. These concerns have been brought to the attention of your agency by professionals such as Teachers, lawyers, Psychological professionals, as well as Mental health workers.

Your Agency has :


- 1. Neglected its duty to thoroughly investigate concerns raised by members of the community.**
- 2. Neglected to properly intervene in an attempt to ensure the safety and well being of these children.**
- 3. Workers of your agency have turned a blind eye to obvious abuse at the hands of the mother.**
- 4. Workers of your agency have admitted to realizing that the mother has made numerous untruths to them in an attempt to avoid further suspicion.**

5. **Workers have made statements that the CAS chooses not to intervene in this family due to its Native mother and fear of reprisal in the form of a lawsuit for racial claims.**
6. **Your workers have forced an unwilling , scared, fearful and frightened child to return to the home of an abusive mother within hours of disclosing to police and family doctor that she was physically abused.**
7. **Your workers have provided promises and guarantees to these children as a form of coercion to coax the children (after disclosing abuse) to return the care of the mother, all the while knowing that the child will suffer further abuse at the hands of the mother upon return.**
8. **Your workers have blatantly ignored facts and evidence of abuse.**
9. **Your workers are well aware of the abuse these children suffer on a daily basis.**
10. **Your agency has ignored attempted suicides, threats of suicide, parental neglect, mental and physical abuse, sexual abuse, coercion, corruption of minors as well as mental/ emotional neglect.**
11. **Your agencies workers, by their actions, have not only caused further harm to these children , but have caused these children to not trust the system and to actually fear it.**
12. **Your agencies workers actions have aided and abctted the abuser of these children.**

Dr. [REDACTED] has provided a report (December 2005) to your agency that clarifies the allegations and seriousness of the abuse, that the children have suffered, that your agency has been well aware. The Children's Aid Society of Simcoe County can no longer ignore the abuse these children are suffering.

The Children's Aid Society has a responsibility to these children. Based on the factual information and lengthy duration of repeated and reoccurring allegations of abuse which have been confirmed. The Children's Aid Society must **immediately** intervene and commit these children to care in a foster home that will provide the necessities of life, love, affection and nurturing these three children require. Committal of these children must be of adequate time for a thorough and proper investigation by Police, CAS and Certified Child Psychologists.
