To Whom It May Concern:

Further to my letters of December 27, 2005.

I have been contacted by supervisors in the Orillia branch of your organization requesting that I clarify my intentions of my letter. I believe that my intentions are self explanatory and clearly shown on the last paragraph of my letter.

1. These children need to be taken into the care of the Childrens Aid Society and placed in a foster home.
2. A proper investigation of all of the allegations in the past 30 months to be investigated by legal REGISTERED Social Workers, registered with the Ontario College of Social Workers and Social Service Workers.
3. Police to be involved with all investigations and for the police to not be directed by CAS to cease investigations.
4. The children need to be interviewed out the presence of the mother to ensure integrity as well as remove the "fear factor" that is imposed upon the children.
5. The Workers must provide due diligence in their investigation and ensure confidentiality to the children to ensure that further abuse is not inflicted upon them.
6. Police will provide proper investigations as per the Police Services Act and ensure that the safety of the above children is adhered to.

7. As seen in Dr. Pazaratz letter of December 2005, the above children suffer from Neglect, Abuse, Coercion, and Protection from Harm. Your agency must investigate these concerns in a timely (4 months to date for the latest concerns is not appropriate) manner and thoroughly and completely conduct an investigation.
8. Further involvement with a certified, Registered, Child Psychologist, must be committed.

If your organization is not prepared to protect these children and their rights, under the Child and Family Services Act as well as your organizations own mandate, then I will be forced to take further action against your organization to ensure that my children are protected and provided the services they are entitled to. I assure that I hold your organization accountable for the psychological conditions that my children presently have. I can assure you that I will further hold your Organization liable, if any further harm comes to my children because of your lack of response to multiple concerns for these children.
