Dear Dr. Yarrow;

**Re: Misconduct by your member ██████████ ██████████**

I am lodging a complaint against ██████████ ██████████ for the following reasons:

1. She issued a report that, in all material respects, represented in-absentia assessments of myself, my two sons, ██████████ and ██████████, and my daughter, ██████████. These were carried out without our knowledge or consent. In accepting ██████████ ██████████ information as true and basing her diagnosis and recommendations upon this information, she has simultaneously diagnosed us in ways that are completely false, defamatory, and utterly reprehensible.
2. She affixed her name to a report that she knew, should have known, and could have easily come to know contained false and defamatory information.
3. She created falsified and misleading report containing defamatory information knowing that it would be submitted to Court and indeed specifically prepared the report for that purpose, thereby, with plan and foresight, foisted a falsified and fraudulent document upon the Court.
4. She assisted in attempts to engage in fraud and extortion through producing false diagnoses of disability and claims for compensation.
5. She failed to maintain professional boundaries between herself and her client, ██████████ ██████████, in completely identifying herself with the aims, objectives and goals of her client which were to produce false claims of disability based upon false attribution of causes for said claimed disability.
6. She failed to maintain professional boundaries between herself and the referring lawyer, ██████████ ██████████, in that she completely identified with the aims, objectives and goals of this lawyer in this lawyer's improper attempts to obtain

a professional opinion based upon false, defamatory and misleading, biased and incomplete information, i.e. she acted as a 'hired gun.'

7. She failed to use the tools and procedures of the profession of psychology in the ways for which they were designed and intended in that she, without any probing, questioning, challenging, or investigation, simply accepted as fact all information provided by [REDACTED] [REDACTED].
8. She improperly used her professional qualifications to lend credibility and weight to false information and non-meritorious actions. She acted simply as a conduit for [REDACTED] [REDACTED] information and presented it as a professional report.
9. She engaged in bias in that she suppressed and ignored any information which was inconsistent with the desired outcome of the assessment.
10. She engaged in bias in that she neglected to review document information that could have been easily obtained by her, relying simply upon the client's lawyer to provide biased, one-sided document information.
11. She engaged in bias in that she failed to consider any alternative hypotheses for her findings.
12. She perpetuated child abuse and exploitation in that she demonstrated a willingness to blame children for the mother's emotional condition. She demonstrated a willingness to label children who have been abused, as abusers, and the abuser as the victim, thereby placing her client's objectives for financial gain above her mandated duty to protect children from abuse and exploitation.
13. She provided opinion in areas in which she has no demonstrated expertise, such as disability assessment. In this regard, there was no examination for malingering and no evaluation of skills and accommodations for maximizing her client's autonomous functioning.
14. She engaged in activity which she knew or should have known would exacerbate family tensions, reinforce estrangement and deprive children of fundamental justice in exchange for personal gain.
15. She violated confidentiality of myself, and my children by publishing information of a personal, embarrassing nature, much of which is either completely false or greatly misrepresented without our knowledge or consent, knowing that her report would be seen by multiple persons and could become the subject of discussion, review, examination in court and further dissemination through various forms of transmission.

16. Her actions, in her role as a psychologist in this manner, bearing in mind her prominent position as a psychologist who has served as former council member and president of the College of Psychologists, as member and sometimes head of the discipline committee, as member of discipline panels, brings the profession of psychology into disrepute and contributes to the public's loss of confidence in the profession.
17. While in her role as a psychologist, she engaged in conduct that would be deemed to be dishonourable and discreditable.
18. She demonstrated willingness to engage in actions of callous and depraved indifference to the welfare of others in order to further the improper personal goals of [REDACTED] [REDACTED]
19. She demonstrated willingness to engage in actions of callous and depraved indifference to the suffering of others in order to please the referring lawyer.
20. She demonstrated callous and depraved indifference to the suffering of others in order to obtain personal gain.
21. She has demonstrated such a willingness to sacrifice her training, her duty to protect, her professional standards, her ethical responsibilities that this level of moral compromise and bias must have played a role in her positions of authority within the College of Psychologists, especially within her role as a member of the discipline committee. Therefore, it is incumbent upon the College of Psychologists to review all decision-making of Dr. [REDACTED] in that it can be reasonably assumed that others have had their rights violated and that the College's responsibility to protect the public has been significantly breached.
