

## Background

The “Surviving the horrors of Canada’s Family Court System” information clinic was developed through the combined efforts of many individuals and groups from across Canada having experience in dealing with Canada’s morally corrupt family legal system. The seminar/clinic is designed to be generic in content and intended to be delivered by any group or individual interested in passing on to others the knowledge contained in the course materials.

The information clinic was developed primarily to give family members the knowledge about the family law system to help them counteract the destructive forces they will face when dealing with the Family Court System and other various government and court related agencies.

In Canada, court actions can take months or even years to get through the court system. Child support obligations last for many years and spousal support can last for lifetime.


